DEFENSE BILL

On 12 December 2017, President Trump signed into law the 2018 National Defense Authorization Act (NDAA). The bill was approved by Congress in November and authorizes \$526.4 billion for a base defense budget and \$65.6 billion for a war fund. It increases the size of the Armed Forces for the first time in seven years and provides our Military with their largest pay increase in eight years.

REUNION REGISTRATION

This addition fee is important for us to continue our reunions as attendance decrease from reunion to reunion. Medical problems and Eternal Patrol orders have taken a toll on our shipmates.

FLAG PROTESTS

AMVETS officials are decrying "corporate censorship" from the National Football League for their decision not to run an ad in their Super Bowl program which responds to league players' decision to kneel for the national anthem in protest of national equality issues. The ad, which would have cost the veterans organization \$30,000, features the tag "#PleaseStand" with a picture of service members saluting the American flag and information on how to donate to the congressionally-chartered organization.

In a statement, AMVETS National Commander Marion Polk said the issue is one of fairness and respect. "Freedom of speech works both ways," he said. "We respect the rights of those who choose to protest, as these rights are precisely what our members have fought — and in many cases died — for. "But imposing corporate censorship to deny that same right to those veterans who have secured it for us all is reprehensible and totally beyond the pale."

In a statement, NFL Vice President of Communications, Brian McCarthy, said the Super Bowl game program "is designed for fans to commemorate and celebrate the game, players, teams and the Super Bowl. It's never been a place for advertising that could be considered by some as a political statement." They noted that the program will include a similar ad from the Veterans of Foreign Wars that states simply "We Stand for Veterans." McCarthy said AMVETS was asked to consider changing their ad to read "Please Stand for Our Veterans" but did not reply in time for production deadlines.

Numerous veterans' groups have criticized the flag protests before football games as "disrespectful" to current and former military members. Players involved in the actions have repeatedly said they are not related to service members in any way. The anthem protests began in 2016 when then San Francisco quarterback Colin Kaepernick opted to sit during the anthem singing as a protest against racial inequality and police brutality. At the suggestion of former Staff Sgt. Nate Boyer, who played football in college, Kaepernick opted to change his protest to kneeling during the anthem, echoing troops "taking a knee" during a mission.

President Donald Trump publicly blasted players who followed Kaepernick's lead calling any player involved a "son of a bitch" and suggesting that teams fire them for the actions. The visibility of the protests has ebbed in recent months, after NFL executives met with player representatives to discuss ways the league can better support activism among employees. AMVETS officials said the same #PleaseStand ad was accepted by the National Hockey League and Major League Baseball for inclusion in their all-star games' programs. The organization sees the advertisement as an extension of their role as a "nonpartisan advocate for veterans and their families."

HVAC CHAIRMAN VOWS TO PASS AOBWN BILL THIS YEAR

During a joint House and Senate Veterans Affairs Committee hearing, the Chairman of the House Committee, Phil Roe (Tenn.) said. "I have colleagues who are impacted by this issue. So, let's get this issue off the table this year." The act clarifies service members who served off the coast of Vietnam during the conflict have a presumption for filing disability claims with the Department of Veterans Affairs (VA) for ailments associated with exposure to Agent Orange. Enactment of H.R.299/S.422 will bring a degree of justice to tens of thousands of Navy personnel who have been denied VA services since 2002.

It is unfortunate we must send this message, but clarification is needed in addressing a situation where we have several of our members that are attempting to or have booked passage for our 2018 Convention Cruise through a travel service other than Kim Hedges with AAA, who is our designated agent. The expense and benefits (meeting rooms, hospitality suite, vendor space, etc.) that USSVI incurs/needs to host the up-coming Cruise is no different than any past landlocked convention. Both the expense and benefits are regulated up or down by the number of people that register through the hosting facility we have in place at the event. For the 2018 Cruise that facility is Kim Hedges at AAA Washington. Any bookings outside of AAA will not be registered for the convention and credited to USSVI, which means their attendance does nothing for our organization. Guys, do not try to save a couple of bucks by backdooring a booking through a friends or relatives travel agent, you will not be registered and issued a name tag required to participate in our events and will not be able to participate in any of the convention activities including use of the Hospitality & Vendor Room. Non-Service-Connected Pension

If you are a veteran who is 65 years-old or older, or permanently and totally disabled you may be eligible for the VA Non-Service Connected Disability Pension (NSC)? This is a program that provides financial support to wartime veterans with a limited income. The amount payable under this program depends on the type and amount of income the veteran and his/her family members receive from other sources. Monthly payments are made to bring a veteran's total annual income (including other retirement and Social Security income) to an established level. You may be eligible for the NSC pension if you were discharged from service under other than dishonorable conditions and you served 90 days or more of active duty with at least 1 day during a period of war time, (12/7/1941 - 12/31/1946,6/27/1950 - 1/31/1955, 8/5/1964 - 5/7/1975, 8/2/1990 -1/2/1992). Your countable family income must be below a yearly limit set by law. You may be eligible if you are permanently and totally disabled, OR you are age 65 or older. Probably the most expensive ballast ever carried by a ship was two tons of gold and eighteen tons of silver coins carried by the U.S. submarine TROUT while on a trip from Corregidor to Pearl Harbor early in World War II. TROUT had removed her moveable ballast to allow for a larger cargo of ammunition to be transported for the defenders on the embattled island. LCDR. Fenno, TROUT's CO, planned on replacing the ballast with sand bags, but found none were available. The gold and silver from the Bank of the Philippines was substituted as ballast, which also solved the problem of removing the treasure to a safe place prior to invasion by the enemy.
